## **Other Requirements:**

**\*Crafters:** Please list exactly the type of items that you plan to sell. Crafters do need a New York State tax certificate on display at the market, if you collect sales tax.

**\*Prepared food vendors:** Please list the prepared foods that you intend to sell. You are responsible for contacting the Wayne County Health Dept., becoming acquainted with and following laws that apply to you. Food vendors must have and display their New York State tax certificate and either food service or health certificate.

**\*Produce vendors:** you **MUST** have a New York State tax certificate on display at the market if you are selling taxable goods.

**Cost for a market space will be \$125.00 for the entire 2024 season** (This is \$75.00 savings for 20 weeks.)

Please submit your yearly payment by May 31<sup>st</sup>, 2024. The vendor fee for a weekly market space price is \$10.

**Please make checks out to: Lyons Main Street Program.**
